D. This Amendment was duly adopted by the Owners at Millstone Manor Condominiums in compliance with Article 1*S*, Section I5.1 of the Declaration.

AMENDMENT

Section 9.16{bl of the Declaration is hereby amended to read as follows:

(b) For the safety, health, protection, and quiet enjoyment of all Owners and residents, Unit occupancy shall be limited to two (l) person per bedroom. Any Unit loft areas without window Ingress/egress meeting fire code standards shall not be considered to be bedrooms. In the event this restriction may cause undue hardship due to unusual circumstances, the Owner of any Unit may appeal to the Board of Directors (or exception to this policy. In case appeal, the decision of the Board of Directors shall be final.
